

INTRODUCTION

Airbus Defence and Space GmbH (also known as, "Airbus", or "we" or "us") appreciate your interest in our products, services and business lines. Your privacy is important to us and we want you to feel comfortable using our Radar Constellation Imagery Services.

Airbus is committed to protecting the rights of individuals in line with the **General Data Protection Regulation (reference EU2016/679)** of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of Personal Data and on the free movement of such data (hereinafter referred as : "GDPR") as well as each applicable national Personal Data protection laws and regulations (collectively referred as "Data Protection Laws and Regulations"). The protection of your privacy and Personal Data is an important concern to which we pay special attention throughout our processes.

However, the Radar Constellation Imagery Services might include links to other websites or applications which are not necessarily covered by this Privacy Notice. In this event, we encourage you to carefully read the privacy policies of such websites.

This Privacy Notice will inform you of the Personal Data we collect when you access/use our Radar Constellation Imagery Services; how we use and disclose your Personal Data; how you can control the use and disclosure of your Personal Data; and how we protect your Personal Data.

WHAT PERSONAL INFORMATION DO WE PROCESS?

To provide Radar Constellation Imagery Services we collect and process exclusively business relevant Personal Data. Personal Data we collect and process under this Privacy Notice are as follows:

- **Identification data:** *First name, surname*
- **Professional data:** *Company name, business phone number, email address, company address*
- **IT data/Digital activity data:** *IP address, Logs, Messages sent, Shape file upload, Area of interest, Search parameters, Type of request, Domain, Personal data to identify users*
- **Account information:** *Authentication information, Login, Password*
- **Payment Data:** *Data necessary to process the payment in case of purchases*

HOW DO WE COLLECT PERSONAL DATA?

Airbus may collect these Personal Data directly from you through your registrations on our OneAtlas platform and/or OneAtlas Radar Tasking & Archive portal or through our Customer Service Team.

Airbus automatically receives certain information submitted by your browser when you visit, use, or navigate on our OneAtlas Radar Tasking & Archive portal. This information does not reveal your specific identity (like your name or contact information) but may include device and usage information, such as your IP address, browser and device characteristics, operating system, language preferences, referring URLs, device name, country, location (imprecise).

The information we collect through cookies is limited to a technically necessary session cookie. This information is needed to maintain the security and operation of our Services

DO WE PROCESS ANY SENSITIVE PERSONAL DATA?

Airbus does not collect and process sensitive personal information.

HOW DO WE PROCESS DATA?

We process your information to provide and administer our Services, communicate with you, for security and fraud prevention, and to comply with law. We process your information only when we have a valid legal reason to do so.

- **To facilitate account creation and authentication and to manage user accounts:** *We may process your information so you can create and log in to your account, as well as keep your account in working order.*
- **To respond to user inquiries/offer support to users:** *We may process your information to respond to your inquiries and solve any potential issues you might have with the requested service.*
- **To fulfill and manage your orders:** *We may process your information to fulfill and manage your orders, payments, returns, and exchanges made through the Services.*
- **To protect our Services:** *We may process your information as part of our efforts to keep our Services safe and secure, including fraud monitoring and prevention.*

WHAT IS THE LEGAL BASIS FOR PROCESSING DATA?

The General Data Protection Regulation (GDPR) requires us to explain the valid legal bases we rely on in order to process your personal information.

- **Consent:** *We may process your information if you have given us permission (i.e., consent) to use your personal information for a specific purpose. You can withdraw your consent at any time.*
- **Performance of a Contract:** *We may process your personal information when it is necessary to fulfil contractual obligations to you, including providing our Services or at your request prior to entering into a contract with you.*
- **Legal Obligations:** *We may process your information where we believe it is necessary for compliance with our legal obligations, such as the **German Satellite Data Security Act (SatDSiG)**, to cooperate with a law enforcement body or regulatory agency, exercise or defend our legal rights, or disclose your information as evidence in litigation in which we are involved.*

WHEN AND WITH WHOM DO WE SHARE PERSONAL DATA?

Airbus may share information in specific situations on a need to know basis with the following parties, who perform services for us or on our behalf and require access to such information to perform their work. We have contracts in place with all parties, which are designed to safeguard your personal data.

- Airbus and its affiliates
- Airbus business partner Hisdesat
- Federal Office for Economic Affairs and Export Control (BAFA)⁷⁾
- Third-party business software providers

⁷⁾ As part of the fulfilment of its legal obligations arising from the Satellite Data Security Act (SatDSiG) Airbus is obliged to grant this supervisory authority access to information as part of its examination powers.

IS YOUR INFORMATION TRANSFERRED INTERNATIONALLY?

Our servers are located in Germany. Please be aware that your information may be transferred to, stored, and processed by us in our facilities and by those parties with whom we may share your personal information. These are the Airbus affiliate in France and our business Partner Hisdesat in Spain.

HOW LONG WILL YOUR PERSONAL DATA BE STORED?

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements).

When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymize such

information. Depending on the Services provided to you, we may be required to hold certain data for tax reasons for a period of 10 years.

HOW DO WE KEEP YOUR INFORMATION SAFE?

We have implemented appropriate and reasonable technical and organizational security measures designed to protect the security of any personal information we process.

WHAT ARE YOUR PRIVACY RIGHTS?

Under some circumstances provided by law, you may at any time exercise your data protection rights as listed below:

- **Right to access/obtain a report detailing the information held about you:** *You have the right to obtain confirmation as to whether or not your Personal Data is being processed by Airbus and if so, what specific personal data is being processed.*
- **Right to correct Personal Data:** *You have the right to rectify or request to have rectified any inaccurate Personal Data concerning you.*
- **Right to be forgotten:** *In some cases, for instance, when the Personal Data is no longer necessary in relation to the Purposes for which they were collected, you have the right for your Personal Data to be erased.*
- **Right to data portability:** *You have the right to receive the Personal Data concerning you in a structured, commonly used and machine-readable format and/or transmit those Personal Data to another data controller.*
- **Right to object:** *In some cases required by law, you may ask us to stop processing your Personal Data.*
- **Right to withdraw consent:** *You may at any time withdraw such consent by contacting us at the contact details in section [HOW CAN YOU CONTACT US ABOUT THIS NOTICE?](#) However, please note that this will not affect the lawfulness of the processing before its withdrawal, nor when applicable law allows, will it affect the processing of your personal information conducted in reliance on lawful processing grounds other than consent.*
- **Right to terminate your account:** *You may at any time terminate your account. Upon your request to terminate your account, we will deactivate or delete your account and information from our active databases. However, we may retain some information in our files to prevent fraud, assist with any investigations, enforce our legal terms and/or comply with applicable legal requirements.*
